**A Resolution appropriating \$1,489.37 for the Youth Re-Entry Grant from Ohio Department of Youth Services for programming through 6/30/09, for the Juvenile Court and declaring an emergency.**

WHEREAS, the County of Summit Juvenile Court received grant funds from the Ohio Department of Youth Services, which provides funding to address the challenges and needs of youth transitioning back to their communities from state juvenile correctional facilities; and

WHEREAS, the State Fiscal Year 2008-2009 grant program ended 6/30/09, and an adjustment to salary line appropriation in the amount of \$1,489.37 is needed in order to properly identify income and expenditure within the fund; and

WHEREAS, this Council has determined by reviewing all pertinent information that the aforementioned appropriation is necessary and in the best interest of the County of Summit to appropriate the aforementioned funds;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:


SECTION 5
