13 WHEREAS, the Board of Control, at its meeting held October 28, 2009, awarded a
14 contract to provide the aforementioned services, subject to confirmation by County Council; and,

16 WHEREAS, County Council has determined by reviewing all pertinent information that
17 the contract is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

24 The award by the Board of Control of a professional service contract with Q-Matic
25 Corporation for installation of a client work flow and queuing management system at The Job
26 Center, for the period 10/1/09 to 6/30/10, as Sole Source, approved by the IT Board 10/20/09, in
27 an amount not to exceed \$39,568.19, is hereby confirmed and the County Executive is hereby
28 authorized to execute such contract.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide the aforementioned installation.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,

48 121.22 of the Ohio Revised Code.


