7 **A Resolution confirming the award by the Board of Control of a professional service contract**  
8 **to Intellitech Corp. for cost collection services, in the amount of 25% of monies collected and**  
9 **12% of monies collected on-site, for the Clerk of Courts, and declaring an emergency.**

11 WHEREAS, after receiving Requests for Proposal from 5 vendors for cost-collection  
12 services, the Clerk of Courts wishes to enter into a professional service contract with Intellitech  
13 Corp., in the amount of 25% of monies collected and 12% of monies collected on-site; and

15 WHEREAS, the Board of Control, at its meeting held November 25, 2009, awarded the  
16 aforementioned professional service contract with Intellitech Corp., subject to confirmation by  
17 County Council; and

19 WHEREAS, this Council has determined by reviewing all pertinent information that the  
20 aforementioned contract is necessary and in the best interest of the County of Summit;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of  
23 Ohio, that:

25 SECTION 1

27 The award of a professional service contract to Intellitech Corp. for cost collection services,  
28 in the amount of 25% of monies collected and 12% of monies collected on-site, is hereby confirmed  
29 and the County Executive is hereby authorized to execute such contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
34 welfare of the citizens of the County of Summit, and for the further reason to immediately authorize  
35 a necessary professional service contract for cost collection services for the Clerk of Courts.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take effect  
40 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in  
41 force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating to  
46 the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
47 deliberations of this Council and of any of its committees that resulted in such formal action, were in
