7 **A Resolution confirming an award by the Board of Control of a purchase order with**
8 **METRO Regional Transit Authority for payment of bus passes utilized by work-mandated**
9 **clients, for the period 1/1/10 to 12/31/10, as Best Practical Source, in an amount not to**
10 **exceed \$230,000.00, for the Executive's Department of Job and Family Services, and**
11 **declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held September 8, 2010, awarded a
14 purchase order to provide the aforementioned bus passes, subject to confirmation by County
15 Council; and,

17 WHEREAS, County Council has determined by reviewing all pertinent information that
18 the purchase order is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

23 SECTION 1

25 The award by the Board of Control of a purchase order with METRO Regional Transit
26 Authority for payment of bus passes utilized by work-mandated clients, for the period 1/1/10 to
27 12/31/10, as Best Practical Source, in an amount not to exceed \$230,000.00, is hereby confirmed
28 and the County Executive is hereby authorized to execute such purchase order.

30 SECTION 2

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide the aforementioned bus passes.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

44 It is found and determined that all formal actions of this Council concerning and relating
45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,

48 121.22 of the Ohio Revised Code.
