7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **Aramark Correctional Services for the first renewal of three, for food services at the Jail,**  
9 **for the period 12/1/10 to 11/30/11, as follows: 551-600 meals \$1.056 per meal; 601-650 meals**  
10 **\$1.017 per meal; 651-700 meals \$.986 per meal; 701-750 meals \$.958 per meal; 751+ meals**  
11 **\$.939 per meal, for the Sheriff, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held November 17, 2010, awarded a  
14 contract renewal to provide the aforementioned services, subject to confirmation by County  
15 Council; and,

17 WHEREAS, County Council has determined by reviewing all pertinent information that  
18 the contract renewal is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
21 of Ohio, that:

23 SECTION 1

25 The award by the Board of Control of a purchase contract with Aramark Correctional  
26 Services for the first renewal of three, for food services at the Jail, for the period 12/1/10 to  
27 11/30/11, as follows: 551-600 meals \$1.056 per meal, 601-650 meals \$1.017 per meal; 651-700  
28 meals \$.986 per meal, 701-750 meals \$.958 per meal; 751+ meals \$.939 per meal, is hereby  
29 confirmed and the County Executive is hereby authorized to execute such contract.

31 SECTION 2

33 This Resolution is hereby declared an emergency in the interest of the health, safety and  
34 welfare of the citizens of the County of Summit, and for the further reason to immediately  
35 provide the aforementioned services.

37 SECTION 3

39 Provided this Resolution receives the affirmative vote of eight members, it shall take  
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating  
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
47 deliberations of this Council and of any of its committees that resulted in such formal action,  
48 were in meetings open to the public, in compliance with all legal requirements, including section  
49 121.22 of the Ohio Revised Code.


