7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept an award of federal funds by the Ohio Department of Youth Services of a 2010**  
9 **Juvenile Accountability Block Grant ("JABG") for the period 1/1/11 through 12/31/11, in**  
10 **the amount of \$40,109.00, with a local cash match requirement of \$13,223.00, and**  
11 **appropriating the total of \$53,332.00 for expenditures in 2011, for the Court of Common**  
12 **Pleas-Juvenile Division and declaring an emergency.**

13  
14 WHEREAS, the Ohio Department of Youth Services has awarded a JABG of federal  
15 funds to the Juvenile Court for the period 1/1/11 through 12/31/11, in the amount of \$40,109.00,  
16 with a local cash match requirement of \$13,223.00, to provide for salary and benefits of a  
17 probation officer; and

19 WHEREAS, the JABG funded probation officer will provide probation services to higher  
20 at-risk youth in order to reduce delinquency and recidivism among this population; and

21  
22 WHEREAS, the JABG's local cash match will be provided by the Juvenile Court's  
23 RECLAIM funds; and

25 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
26 necessary and in the best interest of the County of Summit to authorize the Executive to execute  
27 any documents necessary to accept the award of the aforementioned grant from the Ohio  
28 Department of Youth Services, and to appropriate these grant funds;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
31 of Ohio, that:

35 The County Executive is hereby authorized to execute any documents necessary to accept  
36 the award of a 2010 Juvenile Accountability Block Grant ("JABG") award from the Ohio  
37 Department of Youth Services for the period 1/1/11 through 12/31/11, in the amount of  
38 \$40,109.00, with a \$13,223.00 local cash match requirement.
