7 **A Resolution authorizing the County Executive to advertise for bids for Heating,**
8 **Ventilation and Air Conditioning (“HVAC”) maintenance at the County of Summit**
9 **Juvenile Court Facility for a five-year period, for an estimated cost not to exceed**
10 **\$42,000.00 per year, for a total estimated amount not to exceed \$210,000.00, in Council**
11 **District 2, for the Executive’s Department of Administrative Services, and declaring an**
12 **emergency.**

14 WHEREAS, the County of Summit desires to authorize the County Executive to
15 advertise for bids for Heating, Ventilation and Air Conditioning (“HVAC”) maintenance at the
16 County of Summit Juvenile Court Facility for a five-year period, for an estimated cost not to
17 exceed \$42,000.00 per year, for a total estimated amount not to exceed \$210,000.00; and

19 WHEREAS, a copy of the bid specifications are on file in the office of the Clerk of
20 Council; and

22 WHEREAS, this Council has determined by reviewing all pertinent information that it is
23 necessary and in the best interest of the County of Summit to authorize County Executive to
24 advertise for bids for HVAC maintenance at the County of Summit Juvenile Court Facility for a
25 five-year period, for an estimated cost not to exceed \$42,000.00 per year, for a total estimated
26 amount not to exceed \$210,000.00;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that;

32 The County Executive is authorized to advertise for bids for Heating, Ventilation and Air
33 Conditioning (“HVAC”) maintenance at the County of Summit Juvenile Court Facility for a
34 five-year period, for an estimated cost not to exceed \$42,000.00 per year, for a total estimated
35 amount not to exceed \$210,000.00, in Council District 2, for the Executive’s Department of
36 Administrative Services.

40 This Resolution is hereby declared an emergency in the interest of the health, safety, and
41 welfare of the citizens of the County of Summit, and for the further reason that it immediately
42 allows for the advertising for bids for HVAC maintenance at the County of Summit Juvenile
43 Court Facility.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.
