7 **A Resolution authorizing the County Executive to advertise for bids for armored car**

10 **\$35,000.00, for the Executive, and declaring an emergency.**

12 WHEREAS, the County of Summit desires to authorize the County Executive to  
13 advertise for bids for armored car services, for offices and agencies of Summit County, for a one-  
14 year contract with two options to renew for an additional one-year term, for an estimated cost not  
15 to exceed \$35,000.00; and

17 WHEREAS, a copy of the bid specifications are on file in the office of the Clerk of  
18 Council; and

20 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
21 necessary and in the best interest of the County of Summit to authorize the County Executive to  
22 advertise for bids for the aforementioned contract;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
25 of Ohio, that;

28 The County Executive is authorized to advertise for bids for armored car services, for  
29 offices and agencies of Summit County, for a one-year contract with two options to renew for an  
30 additional one-year term, for an estimated total cost not to exceed \$35,000.00.

34 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
35 welfare of the citizens of the County of Summit, and for the further reason that it immediately  
36 authorizes the Executive to advertise for bids for armored car services, for offices and agencies  
37 of the County of Summit, for a one-year contract with two options to renew for an additional  
38 one-year term, for an estimated total cost not to exceed \$35,000.00.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take  
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
43 effect and be in force at the earliest time provided by law.
