8 **necessary to assume, effective 1/1/10, on behalf of the County of Summit Law Library**
9 **Resources Board, two professional service contracts with Thomson West (Westlaw) to**
10 **provide on-line legal research services and printed publications for the Board in its**
11 **operation of the Law Library: a professional service contract for on-line legal research**
12 **services for Board staff for the period 12/12/08 through 12/31/10, for an amount not to**
13 **exceed \$771.63/mo. or \$19,020.68 for the term; and a professional service contract for on-**
14 **line legal research services and printed publications for Law Library patrons, for the**
15 **period 12/12/08 through 12/31/10, for an amount not to exceed of \$1982.88/mo. or**
16 **\$47,589.12 for the term, for a total amount not to exceed \$66,609.80, for the Law Library**
17 **Resources Board, and declaring an emergency.**

19 WHEREAS, the Akron Law Library Association previously operated the Law Library,
20 located on the 4th Floor of the County of Summit Courthouse; and

22 WHEREAS, the Ohio General Assembly enacted 2008 Amended Substitute Ohio House
23 Bill 420, which established county law library resource boards to operate law libraries; and

25 WHEREAS, the County of Summit Law Library Resources Board took over operation of
26 the Law Library on 1/1/10; and

27
28 WHEREAS, as part of its operation, it is necessary for the Board to assume, effective
29 1/1/10, the following professional service contracts with Thomson West (Westlaw) to provide
30 on-line legal research services and printed publications for the Board in its operation of the Law
31 Library:

33 1. Professional service contract for on-line legal research services and printed publications
34 for Board staff for the period 12/12/08 through 12/31/10, for an amount not to exceed
35 \$771.63/mo. or \$19,020.68 for the term; and

37 2. Professional service contract for on-line legal research services and printed publications
38 for Law Library patrons, for the period 12/12/08 through 12/31/10, for an amount not to
39 exceed of \$1982.88/mo. or \$47,589.12 for the term.

44 funds; and

9 necessary and in the best interest of the County of Summit to authorize the Executive to execute
10 any documents necessary to assume, effective 1/1/10, on behalf of the Law Library Resources
11 Board, two professional service contracts with Thomson West (Westlaw) to provide on-line legal
12 research services and printed publications for the Board;

19 The County Executive is hereby authorized to execute any documents necessary to
20 assume, effective 1/1/10, on behalf of the County of Summit Law Library Resources Board, the
21 following professional service contracts with Thomson West (Westlaw) to provide on-line legal
22 research services and printed publications for the Board in its operation of the Law Library:


