7 **A Resolution confirming an award by the Board of Control of a purchase order with**
8 **Akron Tractor & Equipment Company for one Holland Model L170 Skid Steer Loader**

10 **Term Pricing, in an amount not to exceed \$27,468.50, for the Executive's Department of**
11 **Environmental Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held April 7, 2010, awarded a purchase
14 order to provide the aforementioned vehicle and trailer, subject to confirmation by County
15 Council; and,

17 WHEREAS, County Council has determined by reviewing all pertinent information that
18 the purchase order is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

25 The award by the Board of Control of a purchase order with Akron Tractor & Equipment
26 Company for one Holland Model L170 Skid Steer Loader with accessories, and one Cam
27 Superline Model 5cam18 Equipment Trailer, Under State Term Pricing, in an amount not to
28 exceed \$27,468.50, is hereby confirmed and the County Executive is hereby authorized to
29 execute such a purchase order.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide the aforementioned vehicle and trailer.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
