7 **A Resolution confirming an award by the Board of Control of a construction contract with**

24 The award by the Board of Control of a construction contract with Gardiner Service
25 Company for a five-year full service HVAC maintenance contract for the Juvenile Court
26 building located at 650 Dan Street, Akron, Ohio 44310, in an amount not to exceed \$146,890.00,
27 in Council District 2, is hereby confirmed and the County Executive is hereby authorized to
28 execute such contract.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide the aforementioned services.

39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.
