25 amount not to exceed \$4,651.31 (increase), for a cumulative increase of \$46,548.95 (.02417%
26 increase), is hereby confirmed and the County Executive is hereby authorized to execute such
27 change order.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide the aforementioned services.

38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.
