7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award of a Violence Against Women Act ("VAWA") grant from the Ohio Office**
9 **of Public Safety/Office of Criminal Justice Services, in the amount of \$42,392.60, in federal**
10 **funding, which requires a 25% local cash match requirement of \$14,130.87, for the period**
11 **1/1/11 through 12/31/11, and appropriating a total of \$56,523.47, which includes the local**
12 **match through 2011, for the Prosecutor, and declaring an emergency.**

14 WHEREAS, the Ohio Office of Public Safety/Office of Criminal Justice Services has
15 awarded the Prosecutor a VAWA grant in the amount of \$42,392.60, which requires a 25% local
16 cash match requirement of \$14,130.87, for the period 1/1/11 through 12/31/11; and

18 WHEREAS, this annual funding supports a victim advocate position in order to provide
19 the mandated services to victims of crime; and

21 WHEREAS, the local match funding has been appropriated in the Prosecutor's operating
22 budget accepted in Resolution No. 2010-497; and

24 WHEREAS, this Council has determined by reviewing all pertinent information that it is
25 necessary and in the best interest of the County of Summit to authorize the Executive to execute
26 any documents necessary to accept the award of the aforementioned grant from the Ohio Office
27 of Public Safety, and to appropriate these grant funds;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that:

34 The County Executive is hereby authorized to execute any documents necessary to accept
35 the Violence Against Women Act grant award from the Ohio Office of Public Safety/Office of
36 Criminal Justice Services, for the period 1/1/11 through 12/31/11, in the amount of \$42,392.60,
37 with a \$14,130.87 local cash match requirement.


