A Resolution amending Resolution 2010-042 to extend the period of time for the Executive to enter into agreements with various employers for participation and reimbursement in the Summit County Department of Job and Family Services Subsidized Employment Program until May 31, 2011, for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, pursuant to Resolution No. 2010-042, this Council authorized the Executive to enter into agreements with various employers for participation and reimbursement in the Summit County Department of Job and Family Services Subsidized Employment Program from November 1, 2009 through September 30, 2010; and

WHEREAS, pursuant to Resolution Nos. 2009-469 and 2010-352, this Council appropriated funds in the collective amount of \$584,135.50 out of TANF/SEP funds received from the State to fund said agreements; and

WHEREAS, the State of Ohio has extended the timeframe within which to spend said funds until May 31, 2011, and it is necessary to concurrently extend the period of time for the Executive to enter into the aforementioned agreements; and

WHEREAS, this Council finds and determines that it is necessary and in the best interest of this Council to amend Resolution 2010-042 to extend the period of time for the County Executive to enter into agreements with various employers for participation and reimbursement in the Summit County Department of Job and Family Services Subsidized Employment Program until May 31, 2011.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

SECTION 1

Resolution 2010-042 is hereby amended to extend the period of time for the Executive to enter into agreements with various employers for participation and reimbursement in the Summit County Department of Job and Family Services Subsidized Employment Program until May 31, 2011.

SECTION 2

This Resolution is hereby declared to be an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further reason that it is necessary to immediately amend the aforementioned Resolution to allow for the extension of the aforementioned agreements.
