7 **A Resolution confirming an award by the Board of Control of a purchase order with Zep**
8 **Sales & Service for miscellaneous cleaning and custodial supplies under CUE pricing, in an**

11 WHEREAS, the Board of Control, at its meeting held January 12, 2011, awarded a
12 purchase order to provide the aforementioned supplies, subject to confirmation by County
13 Council; and,

15 WHEREAS, County Council has determined by reviewing all pertinent information that
16 the purchase order is necessary and in the best interest of the County of Summit;

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
19 of Ohio, that:

23 The award by the Board of Control of a purchase order with Zep Sales & Service for
24 miscellaneous cleaning and custodial supplies under CUE pricing, in an amount not to exceed
25 \$80,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such
26 purchase order.

30 This Resolution is hereby declared an emergency in the interest of the health, safety and
31 welfare of the citizens of the County of Summit, and for the further reason to immediately
32 provide the aforementioned supplies.

36 Provided this Resolution receives the affirmative vote of eight members, it shall take
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
38 effect and be in force at the earliest time provided by law.

42 It is found and determined that all formal actions of this Council concerning and relating
43 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
44 deliberations of this Council and of any of its committees that resulted in such formal action,
45 were in meetings open to the public, in compliance with all legal requirements, including Section
46 121.22 of the Ohio Revised Code.




