7 **A Resolution confirming an award by the Board of Control of Change Order No. 1 with**  
8 **AA1 Commercial, Inc., for snow removal at various County facilities, in Council Districts**

13 order provide the aforementioned services, subject to confirmation by County Council; and,

23 The award by the Board of Control of Change Order No. 1 with AA1 Commercial, Inc.,  
24 for snow removal at various County facilities, in Council Districts 2, 4, 5 and 6, in an amount not  
25 to exceed \$15,000.00 (60% increase), is hereby confirmed and the County Executive is hereby  
26 authorized to execute such change order.

30 This Resolution is hereby declared an emergency in the interest of the health, safety and  
31 welfare of the citizens of the County of Summit, and for the further reason to immediately  
32 provide the aforementioned services.

36 Provided this Resolution receives the affirmative vote of eight members, it shall take  
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
38 effect and be in force at the earliest time provided by law.

42 It is found and determined that all formal actions of this Council concerning and relating  
43 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
44 deliberations of this Council and of any of its committees that resulted in such formal action,

46 121.22 of the Ohio Revised Code.


