10 **and disability program navigator services, for the period 7/1/11 to 9/30/11, in an amount**
11 **not to exceed \$243,646.75 (25% increase), for the Executive's Department of Job and**

15 order provide the aforementioned services, subject to confirmation by County Council; and,

17 WHEREAS, County Council has determined by reviewing all pertinent information that
18 the change order is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

25 The award by the Board of Control of Change Order No. 1 with The Goodwill Industries
26 of Akron, Ohio, Inc., for an extension and second and final renewal for Job Center employment
27 services for WIA-eligible adult and dislocated workers and disability program navigator services,
28 for the period 7/1/11 to 9/30/11, in an amount not to exceed \$243,646.75 (25% increase), is
29 hereby confirmed and the County Executive is hereby authorized to execute such change order.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide the aforementioned services.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.
