7 **A Resolution extending and fixing the date for the submission of the County Engineer's**
8 **final report, plans and schedules for the work to be performed on the Treecrest Drive ditch**
9 **as 12/31/11, for the Engineer, and declaring an emergency.**

11 WHEREAS, on 1/31/11, this Council adopted Ordinance No. 2011-004, wherein in it
12 granted Bath Township's Treecrest Drive ditch petition, in accordance with Section 6131.12 of
13 the Ohio Revised Code; and

15 WHEREAS, pursuant to Ordinance No. 2011-004, this Council fixed the date for the
16 submission of the County Engineer's final report, plans and schedules for the work to be
17 performed on the Treecrest Drive ditch as 6/13/11; and

18
19 WHEREAS, the Engineer's Office has informed the Clerk of Council that additional time
20 is needed to prepare the final report, plans and schedules, and has requested that the time to
21 prepare the same be extended to 12/31/11; and

23 WHEREAS, Section 6131.12 of the Ohio Revised Code permits this Council to extend
24 the date for the submission of the final report, plans and schedules; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information
27 that it is necessary and in the best interest of the County to extend the date for the submission of
28 the Engineer's final report, plans and schedules for the work to be performed on the Treecrest
29 Drive ditch to 12/31/11;

31 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
32 State of Ohio, that:

36 The date for the submission of the County Engineer's final report, plans and schedules
37 for the work to be performed on the Treecrest Drive ditch is hereby extended to and fixed as
38 12/31/11.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and
43 welfare of the citizens of the County of Summit, and for the further reason that the original date
44 for the submission of the final report, plans and schedules has already expired and immediately
45 needs to be extended.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
51 effect and be in force at the earliest time provided by law.
