7 **A Resolution authorizing the County Executive to execute a contract with ICSolutions,**  
8 **subject to the approval of the Board of Control, for inmate pay phone services at the**  
9 **County of Summit Jail, for the period of 7/15/11 to 7/14/12, at a commission rate of 70%,**  
10 **and rejecting Securus Technologies, Inc., as a non-responsive bidder, for the Sheriff, and**  
11 **declaring an emergency.**

13 WHEREAS, the Board of Control, at its special meeting held June 24, 2011, awarded a  
14 contract to provide the aforementioned services and rejected Securus Technologies, Inc., as a  
15 non-responsive bidder; and,

17 WHEREAS, County Council has determined by reviewing all pertinent information that  
18 the contract is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
21 of Ohio, that:

23 SECTION 1

25 The County Executive is hereby authorized to execute a contract with ICSolutions,  
26 subject to the approval of the Board of Control, for inmate pay phone services at the County of  
27 Summit Jail, for the period of 7/15/11 to 7/14/12, at a commission rate of 70%. Furthermore,  
28 this Council hereby rejects the bid of Securus Technologies, Inc., as a non-responsive bidder.

30 SECTION 2

32 This Resolution is hereby declared an emergency in the interest of the health, safety and  
33 welfare of the citizens of the County of Summit, and for the further purpose to immediately  
34 provide inmate phone services at the County Jail.

36 SECTION 3

38 Provided this Resolution receives the affirmative vote of eight members, it shall take  
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
40 effect and be in force at the earliest time provided by law.

44 It is found and determined that all formal actions of this Council concerning and relating  
45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
46 deliberations of this Council and of any of its committees that resulted in such formal action,  
47 were in meetings open to the public, in compliance with all legal requirements, including Section  
48 121.22 of the Ohio Revised Code.

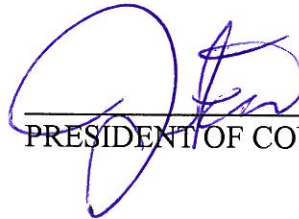
