7 **A Resolution assessing the residents of Glencairn Forest Phase VI, located in Richfield**
8 **Township, Council District 1, for drainage maintenance, for the Engineer, and declaring**
9 **an emergency.**

11 WHEREAS, County Council previously adopted Resolution No. 1998-687, which
12 approved the plat for Glencairn Forest Phase VI; and

13
14 WHEREAS, said plat includes a drainage maintenance assessment provision signed by
15 all owners of parcels located within said subdivision, with said provision applying to
16 subsequent owners of the same parcels; and

17
18 WHEREAS, assessments for drainage maintenance also are permitted by Sections
19 6137.02 and 6137.03 of the Ohio Revised Code; and

20
21 WHEREAS, the County Engineer seeks to establish a drainage maintenance fund for
22 said subdivision and to fully execute its powers and duties thereof; and

24 WHEREAS, the Engineer has prepared a Special Assessment Worksheet, which is
25 attached and marked as Exhibit A, which apportions necessary charges for drainage
26 maintenance among the subdivision's benefited parcel owners; and

28 WHEREAS, this Council has determined by reviewing all pertinent information that it
29 is necessary and in the best interest of the County of Summit to assess the residents of the
30 Glencairn Forest Phase VI subdivision for the aforementioned reasons;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

35 SECTION 1

37 A drainage maintenance fund for Glencairn Forest Phase VI, located in Richfield
38 Township, Council District 1, is hereby established.

42 Owners of parcels within Glencairn Forest Phase VI shall be assessed for drainage
43 maintenance per the attached Special Assessment Worksheet, Exhibit A hereof. Each
44 assessment is proportional to the estimated benefit to the respective parcel.

48 Pursuant to Section 6137.03 of the Ohio Revised Code, the Clerk of Council shall
49 certify the attached assessments to the County Fiscal Officer for placement on the next
50 succeeding tax duplicate to be collected and paid.


