7 **A Resolution authorizing the County Executive to advertise for bids for uniform services**  
8 **for a three-year period, with one option to renew for an additional three-year period, for**  
9 **an estimated total cost not exceed \$90,000.00, for the Executive's Department of**  
10 **Environmental Services, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
13 requires this Council's authorization for the County Executive to advertise for bids; and

14  
15 WHEREAS, the County Executive wishes to advertise for bids for uniform services for a  
16 three-year period, with one option to renew for an additional three-year period, for an estimated  
17 total cost not to exceed \$90,000.00; and

18  
19 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
20 necessary and in the best interest of the County of Summit to authorize the Executive to advertise  
21 for bids for the aforementioned uniform services;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
24 of Ohio, that:

26 SECTION 1

28 The County Executive is hereby authorized to advertise for bids for uniform services for  
29 a three-year period, with one option to renew for an additional three-year period, for an estimated  
30 total cost not to exceed cost of \$90,000.00.

32 SECTION 2

34 This Resolution is hereby declared an emergency in the interest of the health, safety and  
35 welfare of the citizens of the County of Summit, and for the further purpose of immediately  
36 advertising for bids for the aforementioned uniform services.

38 SECTION 3

40 Provided this Resolution receives the affirmative vote of eight members, it shall take  
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
42 effect and be in force at the earliest time provided by law.

44 SECTION 4

46 It is found and determined that all formal actions of the Council concerning and relating  
47 to the adoption of the Resolution were adopted in an open meeting of this Council, and that all  
48 deliberations of this Council and of any of its committees that resulted in such formal action,  
49 were in meetings open to the public, in compliance with all legal requirements, including Section  
50 121.22 of the Ohio Revised Code.


