7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**  
8 **Summit, entitled, "Temporary Hiring Freeze," to authorize the County Executive to hire**  
9 **an external person into the full-time bargaining unit position of Assistant Poundkeeper,**  
10 **#B2113, in the Department of Administrative Services, Animal Control Division, at a salary**  
11 **of \$16.01 per hour or \$33,300.00 annually, for the Executive's Department of**  
12 **Administrative Services, Animal Control Division, and declaring an emergency.**

13  
14 WHEREAS, this Council previously adopted Ordinance No. 2009-110, which enacted  
15 Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled, "Temporary  
16 Hiring Freeze," to control and reduce the County's budget deficit and Ordinance No. 2011-204,  
17 which reinstated the hiring freeze through December 31, 2012; and

18  
19 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that  
20 the filling of an existing position by hiring an employee is necessary for the effective and  
21 continued operation of the office, Council may adopt a Resolution authorizing the office to hire  
22 said employee; and

23  
24 WHEREAS, there is an available vacancy in the position of Assistant Poundkeeper,  
25 #B2113, in the County Executive's Department of Administrative Services, Animal Control  
26 Division, due to the transfer of the previous holder of the position elsewhere in the County; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
29 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
30 hire an external person into the full-time bargaining unit position of Assistant Poundkeeper,  
31 #B2113, in the Department of Administrative Services, Animal Control Division, at a salary of  
32 \$16.01 per hour or \$33,300.00 annually;

34 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,  
35 State of Ohio, that:

39 County Council hereby determines that the County Executive has demonstrated that it is  
40 necessary for the effective and continued operation of his office to authorize the County  
41 Executive, pursuant to Section 169.04(j) of the Codified Ordinance, to hire an external person  
42 into the full-time bargaining unit position of Assistant Poundkeeper, #B2113, in the Department  
43 of Administrative Services, Animal Control Division, at a salary of \$16.01 per hour or  
44 \$33,300.00 annually, within the Executive's 2012 targeted budget.

48 This Resolution is hereby declared an emergency in the interest of the health, safety and  
49 welfare of the citizens of the County of Summit and for the further reason to immediately  
50 authorize the Executive to hire an external person to fill the vacant position of Assistant  
51 Poundkeeper.

8 and be in force at the earliest time provided by law.


