7 **A Resolution declaring the week of March 4-10, 2012, as National Consumer Protection**
8 **Week, for the Executive and the Office of Consumer Affairs, and declaring an emergency.**

10 WHEREAS, national consumer advocacy organizations launch the fourteenth annual
11 National Consumer Protection Week, March 4-10, 2012; and

13 WHEREAS, National Consumer Protection Week is a coordinated campaign that
14 encourages consumers nationwide to take full advantage of their consumer rights and make
15 better-informed decisions; and

17 WHEREAS, in recognition of the County's commitment to protecting and educating
18 Summit County residents on how to protect their privacy, manage money and debt, understand
19 credit and mortgages, and to encourage Summit County residences to avoid identity theft, steer
20 clear of scams, and to utilize the services offered by the Office of Consumer Affairs, this Council
21 desires to declare March 4-10, 2012 as the National Consumer Protection Week; and

23 WHEREAS, this Council finds and determines, by reviewing all pertinent information,
24 that declaring the week of March 4-10, 2012, as National Consumer Protection Week is
25 necessary and in the best interest of the County of Summit;

27 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
28 State of Ohio, that:

32 The week of March 4-10, 2012, is hereby declared National Consumer Protection Week
33 and Summit County residents are hereby encouraged to reach out for help, report frauds or
34 scams, and to utilize the services offered by the Office of Consumer Affairs.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and
39 welfare of the citizens of the County of Summit for the further purpose of immediately declaring
40 March 4-10, 2012, as consumer protection week during said week.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
46 effect and be in force at the earliest time provided by law.


