7 **A Resolution authorizing the County Executive to execute a one-year policing contract with**
8 **the Akron Metropolitan Housing Authority, to provide four full-time Sheriff's Deputies**
9 **and three vehicles, for the period 7/1/12 through 6/30/13, for the total amount of**
10 **\$396,151.00, for the Sheriff, and declaring an emergency.**

11
12 WHEREAS, this Council previously adopted Resolution No. 2012-043, which authorized
13 the County Executive to enter into a policing contract with the Akron Metropolitan Housing
14 Authority ("AMHA") to provide four full-time Sheriff's Deputies, for the period 1/1/12 through
15 6/30/12, in an amount not to exceed \$196,854.00; and

16
17 WHEREAS, the aforementioned agreement expires 6/30/12; and

18
19 WHEREAS, AMHA has requested that the County Executive execute a new agreement
20 to provide four Sheriff's Deputies and three vehicles, for the period 7/1/12 through 6/30/13; and

22 WHEREAS, AMHA has agreed to pay the County the amount of \$32,809.00 per month
23 for total of \$196,854.00, for the six-month period 7/1/12 through 12/31/12, and \$33,216.17 for
24 the period 1/1/13 through 6/30/13 ;

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that the aforementioned agreement is necessary and in the best interest of the County of Summit;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that;

32 SECTION 1

34 The County Executive is hereby authorized to enter into a one-year policing contract with
35 the Akron Metropolitan Housing Authority ("AMHA") to provide four full-time Sheriff's
36 Deputies and three vehicles, for the period 7/1/12 through 6/30/13, for the total amount of
37 \$396,151.00 during the term of the agreement.

39 SECTION 2

41 This Resolution is hereby declared an emergency in the interest of the health, safety, and
42 welfare of the citizens of the County of Summit and for the further purpose of immediately
43 providing necessary policing to AMHA beginning 7/1/12.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
49 effect and be in force at the earliest time provided by law.
