7 **A Resolution adopting the classification, classification specification and salary schedule for**
8 **the exempt classified position of Training Administrator and EEO Compliance Officer**
9 **#90932 at the County Executive's Office, for the Executive's Department of Human**
10 **Resources, and declaring an emergency.**

12 WHEREAS, County Council has the authority pursuant to Article III, Section 3.03(10) of
13 the Charter of the County of Summit and Sections 169.08, 169.09, 169.10, and 169.11 of the
14 Codified Ordinances of the County of Summit, to establish classifications, classification
15 specifications and pay/salary schedules for all County employees; and
16

17 WHEREAS, the County Executive requests that the classification, classification
18 specification and salary schedule for the exempt classified position of Training Administrator
19 and EEO Compliance Officer #90932 at the County Executive's Office be approved by this
20 Council to reflect the consolidation of the EEO Compliance Officer and training supervisor
21 functions in that office; and

23 WHEREAS, at its June 21, 2012 meeting, the County Human Resource Commission
24 ("HRC") approved the creation of the aforementioned and issued HRC Order 12-03 stating the
25 same, which is attached hereto as Exhibit C and incorporated herein as if fully restated;

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary and in the best interest of the County of Summit to adopt the classification,
29 classification specification and salary schedule for the exempt classified position of Training
30 Administrator and EEO Compliance Officer #90932 at the County Executive's Office;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that;

37 The classification for Training Administrator and EEO Compliance Officer #90932 at the
38 County Executive's Office is hereby approved, designated as exempt classified and assigned the
39 salary schedule set forth in Exhibit A, which is attached hereto and incorporated herein as if fully
40 restated.

44 The classification specification for the exempt classified position of Training
45 Administrator and EEO Compliance Officer #90932 at the County Executive's Office, which is
46 attached hereto respectively as Exhibit B and incorporated herein as if fully restated, is hereby


