7 **A Resolution confirming an award by the Board of Control for the renewal (one of one) of**  
8 **various professional service contracts for behavioral health and juvenile justice grant**  
9 **services, with various providers per attached Exhibit A, for the period 7/1/12 to 6/30/13, in**  
10 **a total amount not to exceed \$243,700.00, for the Court of Common Pleas – Juvenile**  
11 **Division, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held June 27, 2012, awarded the  
14 renewal (one of one) of various professional service contracts for behavioral health and juvenile  
15 justice grant services, with various providers per attached Exhibit A, for the period 7/1/12  
16 through 6/30/13, subject to confirmation by County Council; and,

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that the contract renewals are necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control for the renewal (one of one) of various professional  
27 service contracts for behavioral health and juvenile justice grant services, with various providers  
28 per attached Exhibit A, for the period 7/1/12 through 6/30/13, in a total amount not to exceed  
29 \$243,700.00, is hereby confirmed and the County Executive is hereby authorized to execute such  
30 contract renewals.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and  
35 welfare of the citizens of the County of Summit, and for the further reason to immediately  
36 provide for the contract renewals for the period beginning 7/1/12.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take  
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating  
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
48 deliberations of this Council and of any of its committees that resulted in such formal action,

50 121.22 of the Ohio Revised Code.
