7 **A Resolution authorizing the County Executive to execute a second amendment to the**
8 **Sewage Treatment Agreement between the City of Twinsburg and the County of Summit**
9 **dated November 8, 2002, in order to send sanitary sewer flow from the proposed residential**
10 **development known as Steffan Woods in the Township of Twinsburg to the City of**
11 **Twinsburg for treatment and disposal by the City of Twinsburg, in Council District 1, for**
12 **the Executive's Department of Environmental Services, and declaring an emergency.**

14 WHEREAS, the County of Summit ("County") and the City of Twinsburg ("City")
15 entered into a sewage treatment agreement on November 8, 2002 ("Agreement"), in which the
16 City agreed to accept and treat sanitary sewer flow from certain portions of the County's sanitary
17 sewer system; and

18
19 WHEREAS, on or around July 19, 2006, the parties entered into an amendment to the
20 Agreement adding territory that is served under the Agreement; and

21
22 WHEREAS, a residential development that will be known as the Steffan Woods
23 Subdivision, currently located in the County's sanitary sewer district, is planned for construction
24 in the Township of Twinsburg, where it is far more feasible to connect to the City's sanitary
25 sewer system nearby than to the County's sanitary sewer system farther away and uphill; and

27 WHEREAS, the County and City now desire to amend the agreement to allow Twinsburg
28 to accept sanitary sewer flow from the proposed Steffan Woods residential subdivision; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
31 that authorizing the County Executive to execute the second amendment to the sewage treatment
32 agreement of November 8, 2002, between the City and the County, substantially in the form
33 attached to this Resolution as Exhibit "A," is necessary and in the best interest of the County of
34 Summit;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
37 of Ohio, that;

39 SECTION 1

41 The County Executive is authorized to execute a second amendment to the sewage
42 treatment agreement of November 8, 2002, between the City of Twinsburg ("City") and the
43 County of Summit ("County"), substantially in the form attached to this Resolution as Exhibit
44 "A," in order to send sanitary sewer flow from the proposed residential development known as
45 Steffan Woods in the Township of Twinsburg, in Council District 1, to the City for treatment and
46 disposal.

50 This Resolution is declared an emergency in the interest of the health, safety, and welfare
51 of the citizens of the County of Summit, and for the further reason that it allows the residential
52 development known as Steffan Woods to immediately proceed.
