7 **A Resolution confirming an award by the Board of Control of a purchase order with**  
8 **Levinson's Uniforms for the uniform allowance for Sheriff's deputies and supervisors, per**  
9 **Article 27 of the bargaining agreement, as Best Practical Source, in an amount not to**  
10 **exceed \$150,000.00, for the Sheriff, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held February 20, 2013, awarded a  
13 purchase order with Levinson's Uniforms for the uniform allowance for Sheriff's deputies and  
14 supervisors, per Article 27 of the bargaining agreement, as Best Practical Source; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
17 that the purchase order is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
20 of Ohio, that:

24 The award by the Board of Control of a purchase order with Levinson's Uniforms for the  
25 uniform allowance for Sheriff's deputies and supervisors, per Article 27 of the bargaining  
26 agreement, as Best Practical Source, in an amount not to exceed \$150,000.00, is hereby  
27 confirmed and the County Executive is hereby authorized to execute such purchase order.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and  
32 welfare of the citizens of the County of Summit, and for the further reason to immediately  
33 provide for the Sheriff's deputies and supervisors uniform allowance.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take  
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
39 effect and be in force at the earliest time provided by law.

43 It is found and determined that all formal actions of this Council concerning and relating  
44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
45 deliberations of this Council and of any of its committees that resulted in such formal action,  
46 were in meetings open to the public, in compliance with all legal requirements, including Section  
47 121.22 of the Ohio Revised Code.
