7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept an award of federal funds from Policy Research Associates, Inc., for a research**  
9 **grant program, for the period 1/1/13 through 12/31/13, in the amount of \$15,000.00, with**  
10 **no local cash match requirement, and appropriating the total of \$15,000.00 for**  
11 **expenditures in 2013, for the Court of Common Pleas – Juvenile Division and declaring an**  
12 **emergency.**

13  
14 WHEREAS, Policy Research Associates, Inc., (“PRA”) has entered into a research grant  
15 project with funds from the National Institute of Justice (“NIJ”), an agency of the Federal  
16 Department of Justice, and

17  
18 WHEREAS, PRA has subcontracted with the County of Summit Court of Common Pleas  
19 – Juvenile Division (“SCJC”) for a program to assess the effectiveness of four Juvenile Justice  
20 Interventions along with Adult Criminal Justice and Child Welfare Outcomes; and

21  
22 WHEREAS, the PRA contract provides funding for a part-time research associated/law  
23 clerk to perform the data collection and submission activity in the study of the effectiveness of  
24 four types of juvenile justice services: traditional probation, intensive probation, CROSSROADS  
25 and ODYS commitment, and to compare these various approaches on their effectiveness to  
26 subsequent behavior and cost; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
29 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
30 execute any documents necessary to accept the award of the aforementioned grant funds from  
31 PRA and to appropriate these grant funds;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
34 of Ohio, that:

38 The County Executive is hereby authorized to execute any documents necessary to accept  
39 the research grant award from Policy Research Associates, Inc. (“PRA”), for the period 1/1/13  
40 through 12/31/13, in the amount of \$15,000.00, with no local cash match requirement.
