7 **A Resolution approving the award by the Board of Control of a purchase contract with**
8 **LexisNexis for printed publications for the Law Library Resources Board in its operation**
9 **of the Law Library, for 2013, in an estimated amount not to exceed \$30,000.00, as Best**
10 **Practical Source, for the Law Library Resources Board, and declaring an emergency.**

12 WHEREAS, the Akron Law Library Association previously operated the Law Library,
13 located on the fourth floor of the County of Summit Courthouse; and

14
15 WHEREAS, the Ohio General Assembly enacted 2008 Amended Substitute Ohio House
16 Bill 420, which established county law library resource boards to operate law libraries; and

17
18 WHEREAS, the County of Summit Law Library Resources Board took over operation of
19 the Law Library on 1/1/10; and

20
21 WHEREAS, as part of its operation, it is necessary for the Board to purchase printed
22 publications; and

24 WHEREAS, the Board of Control, at its February 27, 2013 meeting, awarded a purchase
25 contract with LexisNexis for printed publications for the Law Library Resources Board in its
26 operation of the Law Library, for 2013, in an estimated amount not to exceed \$30,000.00, as
27 Best Practical Source; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary and in the best interest of the County to approve the award by the Board of
31 Control of the aforementioned purchase contract to LexisNexis;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that:

38 The award of a purchase contract with LexisNexis for printed publications for the Law
39 Library Resources Board in its operation of the Law Library, for 2013, in an estimated amount
40 not to exceed \$30,000.00, as Best Practical Source, is hereby approved. The County Executive is
41 hereby authorized to execute any documents necessary to approve the purchase by the Board of
42 printed publications from LexisNexis.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and
47 welfare of the citizens of the County of Summit and for the further purpose of immediately
48 approving the award by the Board of Control of a purchase contract with LexisNexis for the
49 purchase of printed publications by the Law Library Resources Board in 2013 in its operation of
50 the Law Library.
