7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with the County of Summit Domestic Relations Court for a IV-D provider**
9 **contract for the reimbursement of magistrate services, for the period 1/1/13 through**
10 **12/31/13, in an amount not to exceed \$641,966.51, for the Prosecutor – Child Support**
11 **Enforcement Agency, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held February 20, 2013, awarded a
14 professional service contract with the County of Summit Domestic Relations Court for a IV-D
15 provider contract for the reimbursement of magistrate services, for the period 1/1/13 through
16 12/31/13, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a professional service contract with the County of
27 Summit Domestic Relations Court for a IV-D provider contract for the reimbursement of
28 magistrate services, for the period 1/1/13 through 12/31/13, in an amount not to exceed
29 \$641,966.51, is hereby confirmed and the County Executive is hereby authorized to execute such
30 contract.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide for the reimbursement of magistrate services effective 1/1/13.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.
