7 **A Resolution confirming an award by the Board of Control of a 60-month lease with**
8 **ComDoc for ten Xerox copy machines, for the period 4/1/13 through 3/31/18, under**
9 **Sourcing Office, Inc., Pricing, not to exceed \$2,579.50 per month, with any black and white**
10 **impressions over 15,000 per month billed at \$.0049 each, and color impressions billed at**
11 **\$.06 each, for a total amount not to exceed \$175,000.00, for the Court of Common Pleas –**
12 **Juvenile Division, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held March 6, 2013, awarded a 60-
15 month lease with ComDoc for ten Xerox copy machines, for the period 4/1/13 through 3/31/18,
16 under Sourcing Office, Inc., Pricing, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the lease is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a 60-month lease with ComDoc for ten Xerox copy
27 machines, for the period 4/1/13 through 3/31/18, under Sourcing Office, Inc., Pricing, not to
28 exceed \$2,579.50 per month, with any black and white impressions over 15,000 per month billed
29 at \$.0049 each, and color impressions billed at \$.06 each, for a total amount not to exceed
30 \$175,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such
31 lease.

35 This Resolution is hereby declared an emergency in the interest of the health, safety and
36 welfare of the citizens of the County of Summit, and for the further reason to immediately
37 provide for copy machines in 2013.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.

48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
49 deliberations of this Council and of any of its committees that resulted in such formal action,
