7 **A Resolution authorizing the County Executive to execute a one-year policing contract with**
8 **the County of Summit Developmental Disabilities Board, to provide one Sheriff's Deputy**
9 **and one shift vehicle, for the period 3/1/13 through 2/28/14, in Council District 6, in a total**
10 **amount not to exceed \$94,315.65, for the Sheriff, and declaring an emergency.**

12 WHEREAS, this is a new contract with County of Summit Developmental Disabilities
13 Board ("DD Board") and the DD Board is asking to enter into a policing contract with the
14 Sheriff's Office to provide one Sheriff's Deputy, for the period 3/1/13 through 2/28/14, in
15 Council District 6, in the amount of \$94,315.65; and

16
17 WHEREAS, the DD Board has requested that the County Executive execute a new
18 agreement to provide one Sheriff's Deputy and one vehicle for one shift, for the period 3/1/13
19 through 2/28/14; and

21 WHEREAS, the DD Board has agreed to pay the County the amount of \$7,859.64 per
22 month, for total of \$94,315.65, for the period 3/1/13 through 2/28/14, and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that the aforementioned agreement is necessary and in the best interest of the County of Summit;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that;

32 The County Executive is hereby authorized to enter into a one-year policing contract with
33 the County of Summit Developmental Disabilities Board ("DD Board) to provide one full-time
34 Sheriff's Deputy and one vehicle for one shift, for the period 3/1/13 through 2/28/14, in Council
35 District 6, in a total amount not to exceed \$94,315.65.

39 This Resolution is hereby declared an emergency in the interest of the health, safety, and
40 welfare of the citizens of the County of Summit and for the further purpose of immediately
41 providing necessary policing to County of Summit Developmental Disabilities Board effective
42 3/1/13.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.
