7 **A Resolution confirming an award by the Board of Control of purchase contract with**  
8 **Kenworth of Richfield for four 2013 single axle dump trucks (cab and chassis component),**  
9 **in an amount not to exceed \$383,952.00, for the Engineer, and declaring an emergency.**

11 WHEREAS, the Board of Control, at its meeting held March 27, 2013, awarded a  
12 purchase contract with Kenworth of Richfield for four 2013 single axle dump trucks (cab and  
13 chassis component), subject to confirmation by County Council; and

15 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
16 that the purchase contract is necessary and in the best interest of the County of Summit;

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
19 of Ohio, that:

21 SECTION 1

23 The award by the Board of Control of a purchase contract with Kenworth of Richfield for  
24 four 2013 single axle dump trucks (cab and chassis component), in an amount not to exceed  
25 \$383,952.00, is hereby confirmed and the County Executive is hereby authorized to execute such  
26 purchase contract.

28 SECTION 2

30 This Resolution is hereby declared an emergency in the interest of the health, safety and  
31 welfare of the citizens of the County of Summit, and for the further reason to immediately  
32 provide the dump trucks in 2013.

34 SECTION 3

36 Provided this Resolution receives the affirmative vote of eight members, it shall take  
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
38 effect and be in force at the earliest time provided by law.

42 It is found and determined that all formal actions of this Council concerning and relating  
43 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
44 deliberations of this Council and of any of its committees that resulted in such formal action,  
45 were in meetings open to the public, in compliance with all legal requirements, including Section  
46 121.22 of the Ohio Revised Code.
