7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept an award of federal funds from the Ohio Department of Job and Family Services for**  
9 **a Rapid Response On-the-Job Training grant, in the amount of \$25,000.00, with no local**  
10 **cash match requirement, and appropriating the total of \$25,000.00 for expenditures for the**  
11 **federal fiscal year ending 9/30/13, for the Executive's Department of Job and Family**  
12 **Services, and declaring an emergency.**

14 WHEREAS, the Ohio Department of Job and Family Services ("ODJFS") has awarded a  
15 Rapid Response On-the-Job Training ("OJT") grant of federal funds to the County Executive's  
16 Department of Job and Family Services ("SCDJFS"), for the federal fiscal year ending 9/30/13,  
17 in the amount of \$25,000.00, with no local cash match requirement; and

19 WHEREAS, the additional funding is to provide support for SCDJFS's current OJT  
20 program to encourage successful re-employment strategies for dislocated workers in the  
21 Workforce Investment Act ("WIA") programming; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
25 execute any documents necessary to accept the award of the aforementioned grant from ODJFS  
26 and to appropriate these grant funds;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that:

33 The County Executive is hereby authorized to execute any documents necessary to accept  
34 the award of a Rapid Response On-the-Job Training ("OJT") grant from the Ohio Department of  
35 Job and Family Services ("ODJFS"), for the federal fiscal year ending 9/30/13, in the amount of  
36 \$25,000.00, with no local cash match requirement.
