7 **A Resolution confirming an award by the Board of Control of Change Order No. 1 to a**
8 **professional service contract with the Battered Women's Shelter of Summit and Medina**
9 **Counties for homeless prevention services at various shelters, for the period 10/1/12**
10 **through 9/30/13, in an amount not to exceed \$100,000.00 (50% increase), for the**
11 **Executive's Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held March 27, 2013, awarded Change
14 Order No. 1 to a professional service contract with the Battered Women's Shelter of Summit and
15 Medina Counties for homeless prevention services at various shelters, for the period 10/1/12
16 through 9/30/13, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, by reviewing all pertinent information,
19 that the change order is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

24 SECTION 1

26 The award by the Board of Control of Change Order No. 1 to a professional service
27 contract with the Battered Women's Shelter of Summit and Medina Counties for homeless
28 prevention services at various shelters, for the period 10/1/12 through 9/30/13, in an amount not
29 to exceed \$100,000.00 (50% increase), is hereby confirmed and the County Executive is hereby
30 authorized to execute such change order.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide homeless prevention assistance services in 2013.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,

50 121.22 of the Ohio Revised Code.


