14 professional service contracts for three subrecipient subgrant agreements per attached Exhibit A,
15 for summer youth employment monitor services, for the period 5/15/13 through 12/31/13,
16 subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contracts are necessary and in the best interest of the County of Summit;

26 The award by the Board of Control of a professional service contracts with three
27 subrecipient subgrant agreements per attached Exhibit A, for summer youth employment monitor
28 services, for the period 5/15/13 through 12/31/13, in a total amount not to exceed \$191,800.00, is
29 hereby confirmed and the County Executive is hereby authorized to execute such contracts.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide for summer youth employment monitor services effective 5/15/13.

40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.
