7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with the vendors listed on Exhibit A, for title examination services, for the period**
9 **5/1/13 through 4/30/15, with one two-year renewal option, in an amount not to exceed**
10 **\$250,000.00 per year, with a two-year aggregate total of \$500,000.00, for the Fiscal Officer,**
11 **and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held April 17, 2013, awarded a
14 professional service contract with the vendors listed on Exhibit A, for title examination services,
15 for the period 5/1/13 through 4/30/15, with one two-year renewal option, subject to confirmation
16 by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a professional service contract with the vendors
27 listed on Exhibit A, for title examination services, for the period 5/1/13 through 4/30/15, with
28 one two year renewal option, in an amount not to exceed \$250,000.00 per year, with a two-year
29 aggregate total of \$500,000.00, is hereby confirmed and the County Executive is hereby
30 authorized to execute such contract.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide for title examination services effective 5/1/13.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
