7 **A Resolution authorizing the County Executive to execute an amendment to the collective**  
8 **bargaining agreement between Local 1229 (Communications Technicians Unit) and Ohio**  
9 **Council 8 of the American Federation of State, County and Municipal Employees, AFL-**  
10 **CIO, the County Sheriff and the Executive authorizing a one and one-half percent (1.5%)**  
11 **salary increase for the third year of the agreement, from April 1, 2013 through March 31,**  
12 **2014, for the Executive's Department of Human Resources, and declaring an emergency.**

13  
14 WHEREAS, pursuant to Resolution No. 2011-136, this Council authorized the County  
15 Executive to execute a collective bargaining agreement between Local 1229 (Communications  
16 Technicians Unit) and Ohio Council 8 of the American Federation of State, County and  
17 Municipal Employees, AFL-CIO ("AFSCME"), the County Sheriff and the Executive, for a term  
18 from April 1, 2011 through March 31, 2014; and

20 WHEREAS, the aforementioned collective bargaining agreement provides for a wage  
21 reopener in the third year of the agreement, from April 1, 2013 through March 31, 2014; and

23 WHEREAS, a recent fact-finding decision awarded the bargaining-unit employees in the  
24 County Sheriff's Office that are members of the Fraternal Order of Police, Ohio Labor Council,  
25 Inc. (Deputies' Unit), a pay increase of one and one-half percent (1.5%) for the final year of its  
26 Collective Bargaining Agreement with the County (January 1, 2013 – December 31, 2013); and

28 WHEREAS, for purposes of pay equity, this Council has recently provided the non-  
29 bargaining employees of the County Council, Executive, Fiscal Officer, Prosecutor, Sheriff,  
30 Clerk of Courts, Engineer, Human Resource Commission and Internal Audit Department a one  
31 and one-half percent (1.5%) salary increase; and

33 WHEREAS, for purposes of pay equity, it is necessary to authorize the Executive to  
34 execute an amendment to the collective bargaining agreement between Local 1229  
35 (Communications Technicians Unit) and Ohio Council 8 of AFSCME, the Sheriff and the  
36 Executive authorizing a one and one-half percent (1.5%) salary increase for the third year of the  
37 agreement, from April 1, 2013 through March 31, 2014; and

39 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
40 necessary and in the best interest of the County of Summit to authorize the Executive to execute  
41 the aforementioned amendment to the collective bargaining agreement;

43 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
44 of Ohio, that:

48 The County Executive is hereby authorized to execute an amendment to the collective  
49 bargaining agreement between Local 1229 (Communications Technicians Unit) and Ohio  
50 Council 8 of the American Federation of State, County and Municipal Employees, AFL-CIO  
51 ("AFSCME", the County Sheriff and the Executive, authorizing a one and one-half percent  
52 (1.5%) for the third year of the of the agreement, from April 1, 2013 through March 31, 2014.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further purpose of authorizing a timely necessary amendment to the collective bargaining agreement between Local 1229 (Communications Technicians Unit) and Ohio Council 8 of AFSCME, the Sheriff and the Executive.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 4

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
