7 **A Resolution authorizing a two and one-half percent (2.5%) salary increase for all**  
8 **classified non-bargaining employees of the Clerk of Courts, for the Clerk of Courts, and**  
9 **declaring an emergency.**

11 WHEREAS, the County Clerk of Courts wishes to grant a two and one-half percent  
12 (2.5%) salary increase for all classified non-bargaining employees of the Clerk of Courts; and

13  
14 WHEREAS, salary adjustments and increases for classified non-bargaining employees  
15 must be approved by County Council pursuant to Section 169.07 of the Codified Ordinances of  
16 the County of Summit; and

17  
18 WHEREAS the Director of Finance and Budget has certified the availability of sufficient  
19 appropriated funds for the aforementioned two and one-half percent (2.5%) salary increase; and

20  
21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
22 that it is necessary and in the best interest of the County to authorize a two and one-half percent  
23 (2.5%) salary increase for all classified non-bargaining employees of the Clerk of Courts;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
26 of Ohio, that:

28 SECTION 1

29  
30 The salaries of all classified non-bargaining employees of the Clerk of Courts are hereby  
31 increased by two and one-half percent (2.5%) effective the beginning of the first full pay period  
32 immediately following the effective date of this Resolution.

34 SECTION 2

35  
36 This Resolution is hereby declared an emergency in the interest of the health, safety and  
37 welfare of the citizens of the County of Summit, and for the further reason to compensate and  
38 retain skilled employees of the Clerk of Court's Office.

40 SECTION 3

41  
42 Provided this Resolution receives the affirmative vote of eight members, it shall take effect  
43 immediately upon its adoption and approval by the Executive; otherwise it shall take effect and be  
44 in force at the earliest time provided by law.


