4 WHEREAS, this Council has determined by reviewing all pertinent information  
5 that it is necessary and in the best interest of the County of Summit to amend Section  
6 920.02(a)(91)-(156) to add the definition of a nursing home, amend Section 921.05(f) of  
7 the Codified Ordinances of Summit County to update the standards for grease  
8 interceptors in food establishments, and add Section 921.05(k) of the Codified  
9 Ordinances of the County of Summit to require any newly constructed nursing home to  
10 install a trash trap on its sewer lateral.

11  
12 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of  
13 Summit, State of Ohio, that:

15 SECTION 1

16  
17 Sections 920.02 and 921.05 of the Codified Ordinances of the County of Summit  
18 are hereby amended as shown on Exhibit A, attached hereto and incorporated herein as if  
19 fully restated.

21 SECTION 2

23 This Ordinance is hereby declared an emergency in the interest of the health,  
24 safety and welfare of the citizens of the County of Summit and for the further purpose to  
25 immediately facilitate the protection and preservation of the County's sanitary sewer  
26 system.

28 SECTION 3

30 Provided this Ordinance receives the affirmative vote of eight members, it shall  
31 take effect immediately upon its adoption and approval by the Executive; otherwise, it  
32 shall take effect and be in force at the earliest time provided by law.

34 SECTION 4

36 It is found and determined that all formal actions of this Council concerning and  
37 relating to the adoption of this Ordinance were adopted in an open meeting of this  
38 Council, and that all deliberations of this Council and of any of its committees that  
39 resulted in such formal action, were in meetings open to the public, in compliance with  
40 all legal requirements, including Section 121.22 of the Ohio Revised Code.
