7 **A Resolution authorizing the County Executive to execute a subgrant agreement with the**  
8 **Ohio Department of Job and Family Services for grants received by the Summit County**  
9 **Children Services Board, during State Fiscal Year 2014 and 2015 (7/1/13 through 6/30/15),**  
10 **for the Executive's Department of Job and Family Services , and declaring an emergency.**

11  
12 WHEREAS, Section 5101.21 of the Ohio Revised Code states that, commencing 7/1/08,  
13 the Ohio Department of Job and Family Services may only make grants to counties through  
14 subgrant agreements as described in that Section; and

15  
16 WHEREAS, in conformance with Section 5101.21 of the Ohio Revised Code, the Ohio  
17 Department of Job and Family Services developed a standard subgrant agreement to be executed  
18 by the commissioners of each county prior to receiving Department of Job and Family Services  
19 grant funds; and

21 WHEREAS, the Summit County Children Services Board has received from the Ohio  
22 Department of Job and Family Services the standard subgrant agreement for State Fiscal Year  
23 ("SFY") 2014 and 2015 that sets forth the rights and responsibilities of both the Ohio  
24 Department of Job and Family Services and the Summit County Children Services Board in  
25 relation to any grant that is awarded for SFY 2014 and 2015; and

27 WHEREAS, the Summit County Children Services Board anticipates receiving grant  
28 funds from the Ohio Department of Job and Family Services for SFY 2014 and 2015; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
31 that it is necessary and in the best interest of the County to authorize the County Executive to  
32 execute the aforementioned subgrant agreement for SFY 2014 and 2015;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
35 of Ohio, that:

37 SECTION 1

39 The County Executive is hereby authorized to execute a subgrant agreement with the  
40 Ohio Department of Job and Family Services for grants received by the Summit County Children  
41 Services Board for State Fiscal Year ("SFY") 2014 and 2015 (7/1/13 through 6/30/15). A copy  
42 of said subgrant agreement is attached hereto as Exhibit A and incorporated herein by reference.

46 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
47 welfare of the citizens of the County of Summit, and for the further reason that it is necessary to  
48 immediately execute said subgrant agreement so that the Summit County Children Services  
49 Board is eligible to be awarded grant funds from the Ohio Department of Job and Family  
50 Services for SFY 2014 and 2015.
