7 **A Resolution authorizing the County Executive to execute an amendment to a one-year**
8 **agreement with the Summit County Combined General Health District for the County**
9 **Sheriff's Office to provide one Sheriff's Deputy for community based policing, on a per**
10 **unit basis, related to an Adult Protective Services Pilot Project, from 10/1/12 through**
11 **9/30/13, to add one additional Sheriff's Deputy for a period of 10 weeks (7/22/13 through**
12 **9/20/13), for an additional cost of \$20,000.00, for a new total amount of \$110,000.00, for the**
13 **Sheriff, and declaring an emergency.**

15 WHEREAS, this Council previously adopted Resolution No. 2013-123, which authorized
16 the County Executive to execute a one-year agreement with the Summit County Combined
17 General Health District for the County Sheriff's Office to provide one Sheriff's Deputy for
18 community based policing, on a per unit basis, related to an Adult Protective Services Pilot
19 Project, from 10/1/12 through 9/30/13, with one option to renew for an additional one-year term,
20 for a total amount of \$90,000.00; and

22 WHEREAS, the Health District wishes to add one additional Sheriff's Deputy for a
23 period of 10 weeks (7/22/13 through 9/20/13), for an additional cost of \$20,000.00, for a new
24 total amount of \$110,000.00; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that the aforementioned amendment is necessary and in the best interest of the County of
28 Summit;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that;

35 The County Executive is hereby authorized to execute an amendment to a one-year
36 agreement with the Summit County Combined General Health District for the County Sheriff's
37 Office to provide one Sheriff's Deputy for community based policing, on a per unit basis, related
38 to an Adult Protective Services Pilot Project, from 10/1/12 through 9/30/13, to add one additional
39 Sheriff's Deputy for a period of 10 weeks (7/22/13 through 9/20/13), for an additional cost of
40 \$20,000.00, for a new total amount of \$110,000.00.

44 This Resolution is hereby declared an emergency in the interest of the health, safety, and
45 welfare of the citizens of the County of Summit and for the further purpose of immediately
46 authorizing the execution of a necessary amendment to agreement for the Sheriff Office to

48 County Public Health, related to an Adult Protective Services Pilot Project.

SECTION 4


