7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with the Court of Common Pleas Juvenile Division for the renewal of an**  
9 **intergovernmental agreement to provide youth and family strengthening program services**  
10 **which operate a family resource center model located at the Court, for the period 10/1/13**  
11 **through 9/30/14, in an amount not to exceed \$340,000.00, for the Executive's Department of**  
12 **Job and Family Services, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held August 7, 2013, awarded a  
15 professional service contract with the Court of Common Pleas Juvenile Division for the renewal  
16 of an intergovernmental agreement to provide youth and family strengthening program services  
17 which operate a family resource center model located at the Court, for the period 10/1/13 through  
18 9/30/14, subject to confirmation by County Council; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
21 that the renewal of the agreement is necessary and in the best interest of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
24 of Ohio, that:

28 The award by the Board of Control of a professional service contract with the Court of  
29 Common Pleas Juvenile Division for the renewal of an intergovernmental agreement to provide  
30 youth and family strengthening program services which operate a family resource center model  
31 located at the Court, for the period 10/1/13 through 9/30/14, in an amount not to exceed  
32 \$340,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such  
33 agreement renewal.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and  
38 welfare of the citizens of the County of Summit, and for the further reason to immediately  
39 provide for the renewal of the agreement effective 10/1/13.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take  
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
45 effect and be in force at the earliest time provided by law.


SECTION 4


