7 **A Resolution authorizing the County Executive to advertise for bids for the purchase of one**  
8 **tractor cab and chassis with fifth wheel wet connection, for an estimated total cost not to**  
9 **exceed \$135,000.00, for the Executive's Department of Environmental Services, and**  
10 **declaring an emergency.**

11  
12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
13 requires this Council's authorization for the County Executive to advertise for bids; and

14  
15 WHEREAS, the County Executive wishes to advertise for bids for the purchase of one  
16 tractor cab and chassis with fifth wheel wet connection; and

17  
18 WHEREAS, in Resolution No. 2011-018, County Council approved execution of the  
19 Director's Final Findings and Orders with the Ohio Environmental Protection Agency, in which  
20 the County is required to remove a sludge storage area located on the property of the County's  
21 Springfield Waste Water Treatment Plant No. 36 on or before October 1, 2015; and

22  
23 WHEREAS, the Executive's Department of Environmental Services ("DOES") has  
24 determined it can save substantial costs in the removal of the sludge storage area by purchasing a  
25 tractor to transport the sludge material itself rather than hiring an outside contractor, in addition  
26 to performing a variety of other jobs within the operations of DOES; and

28 WHEREAS, a copy of the technical specifications are attached as Exhibit A; and

29  
30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
31 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
32 advertise for bids for the aforementioned tractor cab and chassis;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
35 of Ohio, that;

37 SECTION 1

39 The County Executive is authorized to advertise for bids for the purchase of one tractor  
40 cab and chassis with fifth wheel wet connection, for an estimated total cost not to exceed  
41 \$135,000.00.

43 SECTION 2

45 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
46 of the citizens of the County of Summit, and for the further reason that it authorizes the  
47 Executive to immediately advertise for bids for the tractor in order to meet an Ohio  
48 Environmental Protection Agency order and for the operational needs of the Executive's  
49 Department of Environmental Services ("DOES").

16 121.22 of the Ohio Revised Code.


