12 WHEREAS, the United States Small Business Association (“SBA”) has established  
13 November 30, 2013 as Small Business Saturday in the United States; and

15 WHEREAS, Small Business Saturday is meant to celebrate and support small businesses  
16 and all that they do for the local community; and

18 WHEREAS, SBA established Small Business Saturday in an effort to help small  
19 businesses prepare for the holiday season with tips for holiday marketing, hiring temporary  
20 workers and gearing up for the holiday season; and

22 WHEREAS, the Executive and this Council wish to share in this collective celebration  
23 and support of local small businesses; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
26 that it is necessary and in the best interest of the County to declare November 30, 2013 as Small  
27 Business Saturday in Summit County and to encourage the citizens of Summit County to support  
28 our local small businesses.

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
31 of Ohio, that:

35 This Council hereby declares November 30, 2013 as Small Business Saturday in Summit  
36 County and encourages the citizens of Summit County to support our local small businesses.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and  
41 welfare of the citizens of the County of Summit, and for the further reason to immediately spread  
42 awareness for Small Business Saturday prior to November 30, 2013.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
48 effect and be in force at the earliest time provided by law.
