7 **A Resolution, pursuant to Section 6131.16 of the Ohio Revised Code, fixing the date of June**
8 **16, 2014, for the final hearing on the Treecrest Drive Ditch Petition and directing the Clerk**
9 **of Council to provide proper notice of the hearing as set forth in Section 6131.16 of the**
10 **Ohio Revised Code, for the Council, and declaring an emergency.**

11
12 WHEREAS, pursuant to Section 6131.12 of the Ohio Revised Code, this Council has the
13 authority to grant a proposed ditch improvement when it is of the opinion that the ditch
14 improvement is necessary, will benefit the petitioner, will be conducive to the public welfare and
15 that the benefits outweigh the costs; and

16
17 WHEREAS, on August 10, 2010, a single County ditch petition was filed with the Clerk
18 of Council requesting the County to clean, remove obstructions from, restore, reconstruct and
19 repair the storm sewer and ditch storm-water drainage system serving all or part of Lots 11, 12,
20 13, 14, 15, 16, 17, 18, 19, 20, and 21 within Yellow Creek Woods, a residential subdivision
21 located in Bath Township, Summit County, Ohio as recorded on Plat Book 65, Pages 31-33 of
22 the records of Summit County, Ohio, including but not limited to the drainage way generally
23 located between Lots 12 and 13 to an adequate outlet all of which generally runs along Treecrest
24 Drive (hereinafter referred to as the "Treecrest Drive Ditch" and "Treecrest Drive Ditch
25 Petition"); and

27 WHEREAS, pursuant to Resolution No. 2011-004, this Council granted the Treecrest
28 Drive Ditch Petition and instructed the County Engineer to begin preparing the final report, plans
29 and schedules as provided in Sections 6131.12, 6131.14 and 6131.16 of the Ohio Revised Code;
30 and

32 WHEREAS, on May 2, 2014, the County Engineer filed with the Clerk of Council the
33 final report, plans and schedules for the Treecrest Ditch Petition; and

35 WHEREAS, pursuant to Section 6131.16 of the Ohio Revised Code, upon the filing with
36 the Clerk of Council of the final report, plans and schedules, this Council shall fix a date when
37 the final hearing on the same shall be held not fewer than 25 nor more than 90 days after the
38 filing of the same; and

40 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
41 that it is necessary and in the best interest of the County of Summit to fix the date of the final
42 hearing on the Treecrest Drive Ditch final report and to direct the Clerk of Council to provide
43 proper notice of the hearing as set forth in Section 6131.16 of the Ohio Revised Code;

45 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
46 of Ohio, that:

50 The final hearing on the final report, plans and schedules for the Treecrest Drive Ditch
51 Petition shall take place at 4:30 pm on June 16, 2014, in the Summit County Council Chambers,
52 175 South Main Street, Seventh Floor, Akron, Ohio 44308.

7 certified mail in the manner and to the persons set forth in Section 6131.16 of the Ohio Revised
8 Code and is further directed to cause to be published in the Akron Beacon Journal notice of final
9 hearing in the manner set forth in Section 6131.16

11 SECTION 3

13 This Resolution is hereby declared an emergency in the interest of the health, safety and
14 welfare of the citizens of the County of Summit, and for the further reason to immediately fix the
15 final hearing date in a timely manner and in the manner and timeframe set forth in Section
16 6131.16 of the Ohio Revised Code.

20 Provided this Resolution receives the affirmative vote of eight members, it shall take
21 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
22 effect and be in force at the earliest time provided by law.

27 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
28 deliberations of this Council and of any of its committees that resulted in such formal action,
