7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award from the Executive’s Department of Job and Family Services, as part of a**
9 **funding collaborative, of a Federal Fiscal Year 2015 Temporary Assistance to Needy**
10 **Families Title XX grant, in the amount of \$156,250.00, with no local cash match**
11 **requirement, for the period 7/1/14 through 9/30/15, and appropriating \$156,250.00, for the**
12 **County of Summit Court of Common Pleas – Juvenile Division, and declaring an**
13 **emergency.**

15 WHEREAS, the County of Summit Court of Common Pleas – Juvenile Division has been
16 awarded a Title XX Temporary Assistance to Needy Families (“TXX/TANF”) grant, from the
17 Executive’s Department of Job and Family Services, for the funding of a local collaborative in
18 providing services to youth referred to the court by the Ohio Department of Youth Services
19 (“ODYS”), in the amount of \$156,250.00, with no local cash match requirement; and

21 WHEREAS, this funding is to employ a case manager to serve approximately 40 youth
22 referred to the court by ODYS, and the case manager works with the ODYS Parole Officers to
23 prepare youth for early release and continues services throughout parole period and beyond to
24 link mentors, ensure educational goals are met, living arrangements are made, job readiness and
25 job placement/higher education/vocational training are procured. Follow-up services continue for
26 one year beyond end of programming; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
30 execute any documents necessary to accept the award of the aforementioned TXX/TANF grant
31 from the Executive’s Department of Job and Family Services, and to appropriate these grant
32 funds;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that:

39 The County Executive is hereby authorized to execute any documents necessary to accept
40 an award from the Executive’s Department of Job and Family Services, as part of a funding
41 collaborative, of a Title XX Temporary Assistance to Needy Families (“TXX/TANF”) grant, in
42 the amount of \$156,250.00, with no local cash match requirement, for the period 7/1/14 through
43 9/30/15.
