7 **A Resolution authorizing the County Executive, through the Executive's Department of**  
8 **Job and Family Services, to transfer an amount not to exceed \$350,000.00 in Title**  
9 **XX/TANF funds to Summit County Children Services, and to execute any documents**  
10 **necessary to effectuate said transfer, for the Executive's Department of Job and Family**  
11 **Services, and declaring an emergency.**

12  
13 WHEREAS, the County Executive's Department of Job and Family Services ("DJFS") is  
14 the recipient of certain Title XX/TANF funds, which it receives as part of its annual allocation;  
15 and

16  
17 WHEREAS, on September 17, 2013, DJFS received an allocation notice from the State,  
18 whereby the State set forth the Title XX/TANF allocations for DJFS for the period 10/1/13  
19 through 9/30/14; and

20  
21 WHEREAS, the September 17, 2013 allocation notice indicates that DJFS has been  
22 allocated Title XX/TANF funds in the amount of \$2,802,362.00 for the period 10/1/13 through  
23 9/30/14; and

24  
25 WHEREAS, DJFS and Summit County Children Services ("SCCS") intend to enter into  
26 an intergovernmental agreement, memorandum of understanding, or such similar document, in  
27 order for SCCS to provide protective services for children and emancipating out of foster care  
28 services; and

29  
30 WHEREAS, in exchange for providing such services, DJFS will transfer an amount not  
31 to exceed \$350,000.00 of Title XX/TANF funds to SCCS to be used for Non-Allocated  
32 Children's costs; and

34 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
35 that it is necessary and in the best interest of the County of Summit to authorize the transfer of an  
36 amount not to exceed \$350,000.00 of Title XX/TANF funds to SCCS, and to authorize the  
37 Executive to execute any documents necessary to effectuate said transfer;

39 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
40 of Ohio, that:

42 SECTION 1

44 The County Executive, through the Department of Job and Family Services, is hereby  
45 authorized to transfer an amount not to exceed \$350,000.00 in Title XX/TANF funds to Summit  
46 County Children Services ("SCCS") to be used for Non-Allocated Children's Services costs, and  
47 the County Executive is further authorized to execute any documents necessary to effectuate said  
48 transfer.

6 This Resolution is hereby declared an emergency in the interest of the health, safety and  
7 welfare of the citizens of the County of Summit and for the further reason to immediately  
8 authorize the transfer of said Title XX/TANF funds to SCCS.

12 Provided this Resolution receives the affirmative vote of eight members, it shall take  
13 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
14 effect and be in force at the earliest time provided by law.

18 It is found and determined that all formal actions of this Council concerning and relating  
19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
20 deliberations of this Council and of any of its committees that resulted in such formal action,  
21 were in meetings open to the public, in compliance with all legal requirements, including Section  
22 121.22 of the Ohio Revised Code.
