7 **A Resolution amending Resolution No. 2014-218 to revise the amount of a purchase**  
8 **contract with The Callos Companies to include the addition of unemployment tax fees, to**  
9 **act as the employer of record and provide payroll services for the 2014 Summer Youth**  
10 **Employment Program, for pass through wages, FICA, Workers Compensation and**  
11 **administrative fees, for the period 5/15/14 through 9/30/14, in a revised amount not to**  
12 **exceed \$1,427,584.13, for the Executive's Department of Job and Family Services, and**  
13 **declaring an emergency.**

15 WHEREAS, the Board of Control, at its meeting on June 11, 2014, awarded the revision  
16 of a purchase contract with The Callos Companies to include the addition of unemployment tax  
17 fees, to act as the employer of record and provide payroll services for the 2014 Summer Youth  
18 Employment Program, for pass through wages, FICA, Workers Compensation and  
19 administrative fees, for the period 5/15/14 through 9/30/14; and

21 WHEREAS, this Council previously passed Resolution No. 2014-218 in the amount of  
22 \$1,362,584.13 for the contract, which did not include unemployment tax fees; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
25 that it is necessary and in the best interest of the County of Summit to amend Resolution No.  
26 2014-218 to revise the amount of the aforesaid purchase contract to \$1,427,584.13;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that:

31 SECTION 1

33 Resolution No. 2014-218 is hereby amended to revise the amount of a purchase contract  
34 with The Callos Companies to include the addition of unemployment tax fees, to act as the  
35 employer of record and provide payroll services for the 2014 Summer Youth Employment  
36 Program, for pass through wages, FICA, Workers Compensation and administrative fees, for the  
37 period 5/15/14 through 9/30/14, in a revised amount not to exceed \$1,427,584.13, and the  
38 County Executive is hereby authorized to execute such revised contract.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and  
43 welfare of the citizens of the County of Summit, and for the further reason to immediately  
44 provide for the addition of unemployment tax fees to the aforesaid contract.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take  
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
50 effect and be in force at the earliest time provided by law.
